



The 2025 Pay for Performance Program

The Meridian Medicaid Plan (Meridian) Pay for Performance (P4P) program rewards contracted partners in care for delivering quality preventive services such as cancer screenings, immunizations, and well-child visits to members.

We listened to your opinions and added an additional, lower target (the 50th percentile) for 2025 to the Meridian P4P incentives for Primary Care Providers. We also have rewards for other providers like OB/GYNs and behavioral health providers, who offer essential services for two key measures.

*Incentives are paid to the Primary Care Provider (PCP) at the provider TIN level. Payments will be made for Q1/Q2 2025, Q3 2025, and final 2025 performance throughout 2025 and 2026.

**Incentives are paid after Measurement Year 2025 is complete with an additional \$50 per numerator compliant member paid to the rendering provider TIN. Payment will be made in late 2026.
