# **Clinical Policy: Doxepin (Silenor)**

## Description

Doxepin (Silenor<sup>®</sup>) is a tricyclic antidepressant.

#### **FDA** Approved Indication(s)

Silenor is indicated for treatment of insomnia characterized by difficulties with sleep maintenance.

#### **Policy/Criteria**

*Provider must submit documentation (such as office chart notes, lab results or other clinical information) supporting that member has met all approval criteria.* 

It is the policy of health plans affiliated with Centene Corporation<sup>®</sup> that Silenor is **medically necessary** when the following criteria are met:

#### I. Initial Approval Criteria

- A. Insomnia (must meet all):
  - 1. Diagnosis of insomnia;
  - 2. Age  $\geq$  18 years;
  - 3. Failure of zolpidem at maximally indicated dose, unless member meets one of the following (a, b, or c):
    - a. Age  $\geq$  65 years;
    - b. Contraindicated or clinically significant adverse effects are experienced;
    - c. Member has a previous history of substance abuse;
  - 4. Member must use doxepin tablets (generic Silenor), unless contraindicated or clinically significant adverse effects are experienced;
  - 5. Dose does not exceed 6 mg (1 tablet) per day.

Approval duration: 6 months

- **B.** Other diagnoses/indications (must meet 1 or 2):
  - 1. If this drug has recently (within the last 6 months) undergone a label change (e.g., newly approved indication, age expansion, new dosing regimen) that is not yet reflected in this policy, refer to one of the following policies (a or b):
    - a. For drugs on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the no coverage criteria policy for the relevant line of business: CP.PMN.255 for Medicaid; or

- b. For drugs NOT on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the non-formulary policy for the relevant line of business:.PMN.16 for Medicaid; or
- 2. If the requested use (e.g., diagnosis, age, dosing regimen) is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized) AND criterion 1 above does not apply, refer to the off-label use policy for the relevant line of business: CP.PMN.53 for Medicaid.

## **II.** Continued Therapy

- A. Insomnia (must meet all):
  - 1. Member meets one of the following (a or b):
    - a. Currently receiving medication via Centene benefit or member has previously met initial approval criteria;
    - b. Member is currently receiving medication and is enrolled in a state and product with continuity of care regulations (*refer to state specific addendums for CC.PHARM.03A and CC.PHARM.03B*);
  - 2. Member is responding positively to therapy;
  - 3. If request is for a dose increase, new dose does not exceed 6 mg (1 tablet) per day.

## Approval duration: 12 months

## **B.** Other diagnoses/indications (must meet 1 or 2):

- 1. If this drug has recently (within the last 6 months) undergone a label change (e.g., newly approved indication, age expansion, new dosing regimen) that is not yet reflected in this policy, refer to one of the following policies (a or b):
  - a. For drugs on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the no coverage criteria policy for the relevant line of business: CP.PMN.255 for Medicaid; or
  - b. For drugs NOT on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the non-formulary policy for the relevant line of business: CP.PMN.16 for Medicaid; or
- 2. If the requested use (e.g., diagnosis, age, dosing regimen) is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized) AND criterion 1 above does not apply, refer to the off-label use policy for the relevant line of business: CP.PMN.53 for Medicaid.

## Approval duration: Duration of request or 12 months (whichever is less); or

## III. Diagnoses/Indications for which coverage is NOT authorized:

A. Non-FDA approved indications, which are not addressed in this policy, unless there is sufficient documentation of efficacy and safety according to the off label use policies – CP.PMN.53 for Medicaid, or evidence of coverage documents.

#### Appendix C: Contraindications/Boxed Warnings

- Contraindication(s):
  - Individuals who have shown hypersensitivity to doxepin HCl, any of its inactive ingredients, or other dibenzoxepines
  - Co-administration with monoamine oxidase inhibitors (MAOIs)
  - Patients with untreated narrow angle glaucoma or severe urinary retention
- Boxed warning(s): none reported
